

Conditions of Donation (General)

§ 1 Scope. (1) Unless special conditions of donation, for example Conditions of Donation (Scholarship), are applicable, these Conditions of Donation (General) ("Conditions of Donation"), as in force at the time of the payment of the donation, shall govern the legal relationship between the respective national chapter (scholarship raising chapter) or the umbrella organisation of Aiducation (individually or collectively "Aiducation") and the donor ("Donor"). (2) The respective national chapter is determined by the place of residence of the Donor. Where, at the time of the payment of the donation, there is no national chapter of Aiducation at the place of residence of the Donor, the legal relationship is established between the Donor and the umbrella organisation of Aiducation. Currently, the following scholarship raising chapters exist:
