Message from the **CEO**

The past year has been an intense period of challenge and transformation for Aiducation International. We faced various difficult situations across our two main focus countries, Kenya and the Philippines, where the impact of elections affected social and economic activity. Furthermore, Europe witnessed a global conflict and rising price levels, which still has far-reaching consequences. But also internally, we underwent significant organizational transitions in Kenya and Switzerland, including the implementation of non-executive board structures. These challengesrequired substantial resources, in addition to the already daunting task of stabilizing our operational activities in the aftermath of COVID-19. As a result, our organization was deeply impacted by these combined factors. Despite the challenges faced, we were determined to overcome them and continue making a meaningful difference in the lives of underprivileged individuals.

To address these challenges, we conducted a Strategy Retreat in the latter half of 2022. This retreat allowed us to identify and tackle both internal and external obstacles, resulting in the development of a clear action plan and strategic growth roadmap. With the resulting project "Scale2Impact," we aim to bridge structural gaps over the next two years to fully unleash the potential of our sustainable and regenerative business model enabling us to create sustainable impact at scale.

And there was also good news, due to a onetime school fee capping triggered by government regulations related to COVID-19, we were able to enroll an additional 35 underprivileged talents in high school. We have secured online and on-site mentorship programs for this talented pool, and we have established a laptop library to support their educational journey.

With a clear action plan, strategic roadmap, and the support of our stakeholders, we are confident in our ability to achieve sustainable and scalable impact. We have also reallocated a portion of the one-time surplus, prompted by Covid-related regulations, into the transformation of Aiducation, ensuring we continue to adapt and grow in our mission.

Our circular impact model has indeed begun to power itself, as Aiducation alumni become leaders, mentors, advanced scholars, entrepreneurs and self-sustaining members of society who give back in kind. With a very particular framework and focused aims, we are seeing a new form of international collaboration take place: beyond charity, to empowerment and impact across thousands of individual lives and many sectors of society.

Just as we search for the most resilient, driven and thoughtful students, Aiducation demonstrates these qualities having persisted through the pandemic and pivoted mentoring programs to online modules, which can support more graduates and entrepreneurs dynamically. In fact, we won the most innovative company in the education industry in 2022 by World Finance Magazine (www.worldfinance.com) for our circular for-impact model, and moreso for our recently-launched goal to empower 1000 young entrepreneurs by 2050.

We are grateful to the Swiss Re Foundation for providing global mentorship and seed startup funds along our re-design of the Start Up Fund. In fact 12 startups in our talent markets have already received funding within our prototype demonstrating the successful approach. The businesses cover the mobility, food and beverage, tech, real estate financing, agriculture and healthcare sectors.

This year as well has been monumental in our ability to see clear impact, first in that we conducted a comprehensive survey across the recipients of an Aiducation scholarship - 962 still active in high school, and 1402 alumni. Having reached 916 alumni, we found that more than 90% are continuing their education, employed, self-employed or involved in startups. This is a huge testament to the efficacy of not only scholarship but mentorship that is fundamental to the success of Aiducation participants.

Partnering with DierkeHouben Leadership Advisors, we ran a weeklong Leadership Academy, in Nairobi, Kenya, which gathered 8 senior professionals and 40 young talents to focus on their motivations, challenges, purpose, self-management, emotional intelligence and envisioning a purpose-driven future summarized by an action plan. It was the second such in-person academy since the onset of the pandemic, and we are thrilled that we can again encourage future talents in Kenya to expand their limits.

Leaders shape the future, and on this note, I'd like to welcome Carole Häusermann as our first non-executive board member in Aiducation International. An experienced entrepreneur with

Our Highlights of 2022

Aiducation raised 153 scholarships in 2022, and a total of 2,447 scholarships since the foundation of Aiducation in 2007 (Jan 2023 status).

More than 80% of our Kenyan graduation class students graduated with a C+ and above, which qualified them for university admission and compared to the average Kenyan student, Aiducation students attained much higher grades in their final exam. The Aiducation high school scholarship enabled them to graduate high school with great results and they have now the chances to apply for government support, such as loans and scholarships.

Aiducation organized 5 Mentorship Academies:

- 2 Swiss Re Corporate Career Academies in Kenya (1) and the Philippines (1)
- 2 Realize Your Potential Academies in Kenya
- 1 DierkeHouben Leadership Academy in Kenva

Aiducation redesigned the Swiss Re Corporate Career Academy 2022: Together with Swiss Re, Aiducation redesigned the Corporate Career Academy from a 1-week program into a fully virtual program and implemented it for the first time in the Philippines. During a period of 6 weeks Aiducation talents and mentors from Swiss Re as well as local experts were able to meet virtually on synchronous and asynchronous sessions focusing on the topic of the individual's corporate career.

Through our partnership with **DierkeHouben** Leadership Advisors, we successfully implemented a week-long Purpose-driven Leadership Academy in Nairobi, Kenya in June 2022. This is the second edition after the pilot Academy in February 2020. The Academy also marked the second fully onsite Aiducation Academy we have launched in Kenya since the emergence of Covid-19. Aiducation redesigned the Start Up Fund as one of the core building blocks of Aiducation's "Lifelong Learning Experience" for its talents in 2021. After completing the Start Up Academy, AiduTalents with the ambition to start their own

business are encouraged to submit their business plans for consideration. This is a unique opportunity to apply the skills they have developed during the Academy to real life and take the first steps towards building their own venture. Successful Stage 1 applicants will not only receive an initial grant to prototype their business, but also enroll into ongoing mentoring activities. Entrepreneurs who manage to implement their ideas and grow their business model are eligible for additional funding and mentoring during theme-based Stage 2 competitions.

In 2022, Aiducation was able to conduct the Stage 1 competition with 6 winners (5 Ghana, 1 Kenva) who got a grant of USD 1,000 each and are currently all still operating. Furthermore, the pilot of Stage 2 saw a total of 17 young entrepreneurs applied with a business idea of which 5 (all from Kenya) winners were announced by end of 2022.

Aiducation and UBS continued partnership on E-Mentoring Program and kicked off the second E-Mentoring cycle together in 2022 focusing on 21 mentor-mentee pairings. UBS will continue the E-Mentoring Program in 2023 with another 15 pairings.

Around 100 Guests attended our Impact Dinner at ETH Zurich. Once again it was a very successful event and raised over 20,000 Swiss Francs and 16 scholarships.

After the launch of GYLA, our Global Young Leaders Alliance, in 2019, the network has continued to grow with 2,483 members by the end of 2022.

Aiducation International was awarded as the most innovative company in the education industry in 2022 by the World Finance Magazine (www.worldfinance.com) for its circular for-impact model, and foremost for its recently launched goal to empower 1,000 Young Entrepreneurs by 2050 (thousandyoungentrepreneurs.org). Thereby, creating social impact by investing into future leaders and businesses.








Aiducation International has awarded over 2.364 merit-based high school scholarships since 2007. These scholarships went to students in Kenya and the Philippines. But where are these talents today? Are they still in their countries? Did they successfully transfer into tertiary education, the job market or become entrepreneurs?

To answer these questions, we surveyed our scholarship alumni between June and August 2022. When surveying current occupation we allowed for multiple answers. This was due to the fact that some alumni engage in several occupations. A large part of the respondents, 568 or 62%, are in further education. The majority of them, 543 (79.8%) in the field of Professional & Applied Sciences.

She is one of the 213 of our scholars who graduated from high school this year. Amongst many other achievements, she also ranked as the best female and top 5 best science students nationally in the national science competition called the Interswitch Spak Competition. Naima has just joined the University of Nairobi to pursue her bachelor's degree in pharmacy.

> My name is Naima Bomu from Mombasa, born in the year 2004. I joined St. Kevin Hill School for my Certificate of Primary Education (KCPE) examinations in 2017. It was never a smooth journey due to the many challenges I encountered but I never gave up keeping in mind that my future depended on me. For that reason. I worked hard in my studies and eventually scored 420 marks in the National examinations. Life became tough and tougher day by day. Both my parents were jobless by then and we were financially unstable. This made me to almost lose hope knowing that I'll never continue with my studies and become the certified medical doctor I had aspired to be.





71 are self-employed representing 8%.The remaining 92 are either unemployed, full-time housewife/ husband, sick, in the army or managing the family business (paid or unpaid).




About the Academy



Knowing this, I gave my all for the preparations and I maximized my participation in the e-CCA. Among the activities that we had, the most significant to me was the preparation for interviews. For this, the mentors introduced the STAR method as a way of answering questions. We also held mock interviews with our co-participants wherein we received meaningful feedback and advice. From these activities, I learned the importance of self-awareness and confidence in interviews.

After several engagements and three interviews, I finally got in! A lot of people say that only the best and the brightest students get to enter this company. This statement makes me proud and humble at the same time. Of course, I am extremely grateful for my answered prayer. However, it also brought a real deal of pressure on me. I wanted to do my best and maximize my learning in this internship.

Roles and accomplishments as an intern at **P&G Company**

As a finance & accounting intern who was assigned to the quality management team, my main project was digitizing the wicked problems in the AMA region. This regional role involved a lot of project management, process improvement, and automation. At first, I did not know anything about the technical tools that I would be using for my projects. Instead of looking at it negatively, I considered it as a huge opportunity to learn and grow. With this story, I realized that the power of YET has always been emphasized both in e-CCA and my internship.

During those three months, some of my classmates who worked in other companies expressed boredom with what they were doing because most of their activities were repetitive, and they felt underutilized. However, it was different for me. Each day was energizing. I learned new things every day, be it technical, professional, social,

for learning, being in a company that teaches me new things every day delighted me. I also had the opportunity to train managers, interns, and new hires for the Continuous Improvement and Innovation projects of the company. On top of that, I am also very much interested in international business, so I really enjoyed my meetings with some colleagues from abroad.

Overall, it was an experience full of growth, fun, and meaningful relationships. I finished my internship with strong results and recognition from our organization. After my final presentation wherein, I presented my whole P&G internship journey including the impact of my projects, I was offered a full-time position as a finance & accounting manager that I can enjoy once I graduate next year. The journey was extremely challenging, but I was able to make my 4-year dream come true with the help and support of many people, including my family, friends, mentors, managers, and benefactors.

Thank you to Aiducation, academy partners and mentors. From the academies that I have attended, I remember one of my mentors saying, "whatever you do, keep it your greatest passion." As I pursue my professional career in the future years, I will see to it to keep these learnings, grit, and growth mindset with me and hopefully, find my way to pay the goodness forward as a form of gratitude for everyone's support that allowed me to come this far.





I joined the university to do an environmental course, so the change was now attuned to something that makes mother earth a better place to live in. The experience and transformation change in myself for the time I have been a part of Aiducation family is phenomenal. I have seen myself growing in confidence and getting a few key approaches to life directly.

application, my efforts bore fruits when the Start Up Fund Stage 2 applications were opened in mid-2022. At this point, I teamed up with a like-minded friend and came up with the idea of San Feed scholars where mentors would come to teach and Limited. San Feed Limited is an agro-based startup that plans to produce highly proteinous animal feeds from organic waste. It incorporates the use





of a special kind of insect fly called the Black Soldier Fly whose larvae are about five times the size of ordinary house fly larvae. It is these larvae that are dried and become nitrogenous feed for fish, pigs and poultry.

With the funds, I will be able to set up a business location where I would be running the day-to-day activities. I will also set up the necessary infrastructure for the processing, storage and marketing of the packaged product.

Our projections of the business are in the near future, San Feed Limited to be a regional supplier of reliable, cost-saving and highly nutritious feeds. We are looking into becoming a model business in the field of a circular and sustainable economy.

We want our brand to be out there competing and grabbing a niche in the waste recycling industry.







By end of 2022 Aiducation has implemented In 2022 we were once again able to conduct 95 Mentorship Academies for high school students and alumni in 5 countries: Kenva. Philippines, Ghana, Tanzania and Uganda.









Ambassadors


